

## **The Valley Chamber Chorale's Covid 19 Liability Singer Form**

I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities have classified singing as a super spreader and possibly dangerous event.

I acknowledge that I must be fully vaccinated (defined as 2 weeks post final injection) with one of the Covid-19 vaccines before starting in-person rehearsals.

I further acknowledge that the VCC has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19.

I further acknowledge that the VCC cannot guarantee that I will not become infected with Coronavirus/Covid-19. I understand that the risk of becoming exposed to and/or infected by Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to VCC singers and their families.

I voluntarily seek to sing with the VCC during the 2021-2022 Season and acknowledge that I may be increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while attending rehearsals and performances.

I acknowledge that if I knowingly have been in contact with a Covid positive person, I must stay at home until completing the necessary quarantine time or quarantined and tested negative for Covid as in accordance with State and CDC guidelines.

Prior to every rehearsal or performance, I might be asked and will attest that:

- I am not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat or new loss of taste or smell.
- I have not been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19. In the event of a covid exposure, I will follow the current guidelines set forth by the MDH regarding covid exposures for vaccinated people.
- I have not been tested or deemed positive with Coronavirus/COVID-19 within the past 2 weeks.

I agree to sign in to record my attendance at each rehearsal and performance.
